*The Applicant guarantees the correctness of the information whether the collection is VAT exempt under the Danish VAT Act. The Applicant must be able to document this.

*The Framework Agreement stipulates special rules for total charging for the service and maximum charging per text message see www.rammeaftalen.dk for amount limits. Further, special rules apply depending on how the donation/the competition is marketed. The Applicant guarantees the observance of the Framework Agreement provisions in connection with the collection.

*The Applicant guarantees that the receiving organization has been approved by the authorities to receive donations under section 8A(2) or 12(3) of the Danish Tax Assessment Act and is able to document it.

*The Applicant guarantees that the receiving organization has been approved by the "Collection Board" (Indsamlingsnævnet) unless the receiving organization is exempt from this.

Members of ISOBRO only need to send an application first time an SMS collection is started. Subsequent changes in keyword etc. does not require new application. Humanitarian versus non-humanitarian collections requires 2 applications.

*This document must be signed by a person authorized to bind the Charity Organization and the Applicant and sent to 4T no later than 10 working days before the launch of the collection service. Documentation for the power to bind the organization must be sent at 4T request.
